

RESOLUTION 2007-02

A RESOLUTION AMENDING THE TOWN OF GREEN MOUNTAIN FALLS FEE SCHEDULE FOR THE MODEL TRAFFIC CODE INFRACTIONS AND MUNICIPAL CODE VIOLATIONS

WHEREAS, the Board of Trustees for the Town of Green Mountain Falls has previously adopted by reference the Revised 2003 Edition of the Model Traffic Code for Colorado Municipalities, Green Mountain Falls Municipal Code, Chapter 8, Article I; and

WHEREAS, after researching fees charged by other law enforcement agencies in the Pikes Peak area, the Marshal's Department has recommended that the Town increase certain fees within the current fee schedule; and

WHEREAS, the last increase to the Model Traffic Code fee structure was in February 1998.

WHEREAS, the Marshal's Department has recommended increases to the current fees assessed for violations within the Town of Green Mountain Falls Municipal Code, Chapter 7, Article IV, Animals and Article V, Dogs; and

WHEREAS, the Marshal's Department proposed fee modifications are submitted as "Exhibit A" for consideration by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF GREEN MOUNTAIN FALLS, COLORADO:

THAT, by this resolution, the Board of Trustees adopts the fees as recommended by the Marshal's Department within "Exhibit A".

THAT, the amended fees will take effect upon passage of this resolution.
